Cello player, orchestra and chamber music player, member of "Agorà" trio, teacher of Chamber Music at Conservatory "Vecchi-Tonelli", Modena (It) and teacher of cello at Conservatory "F. Vittadini", Pavia (It), winner of 3<sup>rd</sup> prize at Luigi Nono Competition in Chamber Music category in 2017.

**PIER GIORGIO CARGNINO** (Italy). Pianist, Vice-President of APS Amici per la Musica, creator and founder of "Luigi Nono" competition

MARCO JORINO (Italy). First flute of RAI National Symphony Orchestra and Art Director of APS "Amici per la Musica".

Members of the Board of Examiners who have a teaching and/or a family relationship with one or more of the competitors must refrain from attending the hearing of these competitors.

### B) AWARDS

CHAMBER MUSIC

**1st PLACE** 2000,00 €, certificate, a concert in the 2025 Concert Season

organized by APS "Amici per la Musica"

**2nd PLACE** 1000,00 € and certificate. **3dr PLACE** 500,00 € and certificate.

SOLO

**1st PLACE** 1200,00 €, certificate, a concert in the 2025 Concert Season

organized by APS "Amici per la Musica".

2nd PLACE600,00 € and certificate.3rd PLACE300,00 € and certificate.

**SPECIAL PRIZE "CONTEMPORARY MUSIC":** 500,00 € and certificate to the best performance of a contemporary piece (composed after 1950) – prize valid for both categories – and one concert in the 2026 Concert Season organized by APS "Amici per la Musica", playing a piece expressly composed by the winner of the International Composition Prize "LUIGI NONO", 2025 Edition.

SPECIAL PRIZE OF EXAMINERS FOR THE BEST STRING PLAYER PERFORMING IN THE SOLO CATHEGORY: a concert as soloist in the concert season of Orchestra Filarmonica Campana, date and details to be defined. For this concert Orchestra Filarmonica Campana will provide a contribution of € 150 for travel expenses, along with a free stay in the town of the concert.

Board of Examiners might decide not to grant one or more awards.

Board of Examiners decisions are final and irrevocable.

In case of "ex aequo" winners, the prize will be shared.

The Board of Examiners' decisions are valid even in case one Examiner is absent. For all prize-concerts only a flat-rate refund of travel expenses up to  $\in$  300 for soloists and up to  $\in$  1000 for groups will be provided. One night stay will be at organization charge.

#### C) COMPETITION CONDUCT AND REGULATION

The "LUIGI NONO" International Chamber Music Competition will take place at AGAMUS, Via La Salle 2, Grugliasco (Turin) on November 7<sup>th</sup>, 8<sup>th</sup>, 9<sup>th</sup>, 2025.

It's open to musicians of any nationality (winner/s of first prizes in past editions are not admitted) born between January 1<sup>st</sup>, 1992 and December 31<sup>st</sup>, 2010 for CHAMBER MUSIC CATEGORY (all components of the group must be born within these time limits); Born between January 1<sup>st</sup> 1996 and December 31<sup>st</sup> 2010 for SOLO CATEGORY.

Categories as follows:

CHAMBER MUSIC: any group, from duo to octet, including max. one piano. For this category, transcripts are allowed only if they are edited at the time of performance at the competition

**SOLO**: soloists playing any instrument, piano included (accompaniment, if any, allowed). For this category transcripts or reductions of concertos for soloists are allowed. NO pianist for accompaniment is made available by the organization.

The minimum number of competitors for each category is 6.

A piano will be made available by the Organization; any other instrument and accessory for the audition/s must be provided for by competitors.

#### Time limit for auditions:

15 minutes for first round, 20 minute for final round. Times of both auditions could be reduced depending on the number of competitors and at examiners discretion. First round: November 7<sup>th</sup> and 8<sup>th</sup>.November 9<sup>th</sup>.

All winners have to play at the Evening Concert on November 9<sup>th</sup> according to sequence and program defined by the examiners; should winners refuse to attend such concert or change Examiners guideline, their awards can be revoked.

# Private video/sound recording are not allowed during all auditions.

No remuneration can be requested for the Evening Concert of for any audio/video recordings made by the organization.

CHAMBER MUSIC CATEGORY (groups from duo to octet):  $\leq$  30,00 membership fee FOR EACH MEMBER +  $\leq$  70,00 contribution to competition organization.

- **4. List of the pieces for both qualifying and final rounds.** The listed pieces CANNOT be changed, unless written notice is given to Competition Secretary at least 5 DAYS before Competition begins.
- 5.Updated artistic Bio.

IT'S MANDATORY TO BE A MEMEBRSHIP OF ASS. AMICI PER LA MUSICA TO APPLY FOR THE COMPETTION. THE REQUEST OF ADMISSION MUST BE FILLED IN AND SENT FOR EVERY MEMBER OF EACH GROUP.

IN CASE OF WITHDRAWAL OF PARTICIPATION, THE MEMBERSHIP FEE (€ 30) CANNOT BE REFUNDED.

#### **E - CHECK IN AT COMPETITION SECRETARY**

Before the beginning of first round auditions, competitors are required to **check in showing:** 

- a valid ID
- 2 copies of the scores of the pieces that are going to be performed (which must be handed over to the examiners).

Upon submitting the application form, competitors fully accept its rules.

#### **APPLICATION FORMALITIES**

Documents required under point D above must be sent.

For all competitors under the age of 18 years old at the date of application, the application must be signed by a parent or by the person exercising parental authority.

## Application forms must be received by midnight (Rome time) on October 12th 2025.

Day and time of first round auditions will be published from October 10<sup>th</sup> on the web site www.amiciperlamusica.com

Travel and lodging expenses are at competitors' charge.


